Re: Aggregated Farm Gate Delivery Reports (AB 1404) Reporting for 2023 Due April 1, 2024.

Dear Agricultural Water Supplier,

This letter is to remind agricultural water suppliers of the annual Aggregated Farm Gate Delivery Report Form submittal requirements and date.

Agricultural water suppliers who supply 2,000 acre-feet or more of irrigation water or water to 2,000 or more irrigated acres are required to submit to the California Department of Water Resources (DWR) an annual report on the aggregated volume of water they delivered to agricultural customers within their service area by **April 1<sup>st</sup>** of each year for the previous calendar year.

This report must be submitted electronically and report on the aggregate volume of water delivered to land overlying each groundwater basin(s) or sub-basin(s) within the agricultural water supplier's service area.

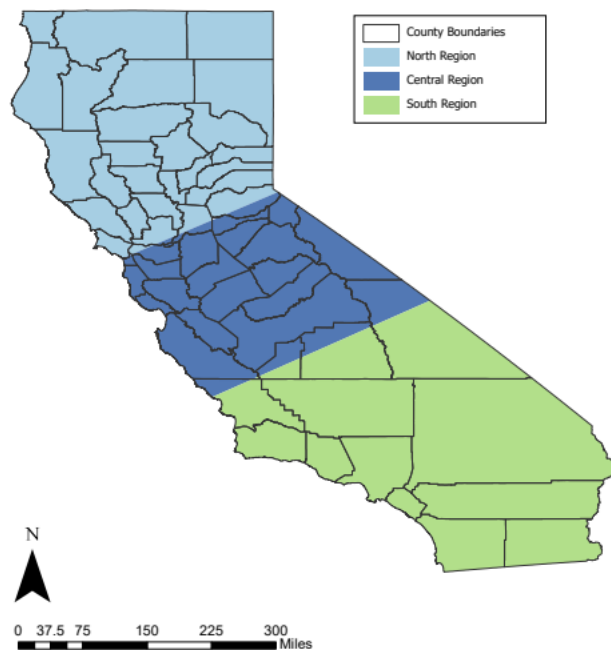
