



Independent science panel will conduct annual review

An independent science panel will conduct the *2015 Long-term Operations Biological Opinions Annual Science Review*, November 5-6, in Sacramento. The purpose of the annual review is to inform the National Marine Fisheries Service and the U.S. Fish and Wildlife Service about the efficacy of water operations and regulatory actions prescribed by their respective Reasonable and Prudent Alternatives. This review provides guidance to ensure that the State investments in flood risk reduction also contribute to long-term improvement of river corridors with net benefit for fish and wildlife. 
Seminar will cover the history of the Delta, 1850-2015
