Sealed bids for FURNISH ROLLER GATES – TEHACHAPI EAST AFTERBAY, ANTELOPE VALLEY, STATE WATER FACILITIES, CALIFORNIA AQUEDUCT, MOJAVE DIVISION, KERN COUNTY, CALIFORNIA, SPECIFICATION NO. 04-18, CONTRACT NO. C51292, will be received by the Department of Water Resources, 1416 Ninth Street, Room 418, Sacramento, California 95814, not later than **2:00 P.M. on WEDNESDAY, DECEMBER 29, 2004**, at which time they will be publicly opened and read at an announced location in the vicinity of such office.

Bid forms for this work are included in a separate booklet titled BID FORM. Bids will be considered only if submitted for all the work required for the above project. The work is defined in Section 01110 – Summary of Work, and includes but is not limited to the following principal features:

1. Designing, manufacturing, factory testing, and delivering two 8 feet wide by 12 feet high, flat leaf, fixed wheel, and rising stem type roller gate assemblies equipped with hydraulic actuators and appurtenances required for complete installation of the roller gate assemblies to Oso Pumping Plant.
2. Designing, manufacturing, and delivering roller gate spare parts and tools to Oso Pumping Plant.
3. Designing, manufacturing, factory testing, and delivering hydraulic power unit (HPU) and appurtenances, common to operate both roller gate assemblies, to Oso Pumping Plant.
4. Designing, manufacturing, factory testing and delivering HPU spare parts and tools to Oso Pumping Plant.
5. Metalwork.
6. Coatings.
7. Electrical work.
8. Services and overtime services of an erecting engineer. and
9. Liaison services.
