Sealed bids for, SEDIMENT REMOVAL, YOLO BYPASS, SACRAMENTO RIVER FLOOD CONTROL PROJECT, FLOOD MANAGEMENT, YOLO COUNTY, CALIFORNIA, SPECIFICATION NO. 06-08, CONTRACT NO. C51319, will be received by the Department of Water Resources, 1416 Ninth Street, Room 418, Sacramento, California 95814, not later than **2:00 P.M. on WEDNESDAY, JUNE 7, 2006**, at which time they will be publicly opened and read at an announced location in the vicinity of such office.

Bid forms for this work are included in a separate booklet titled BID FORM. Bids will be considered only if submitted for all the work required for the above project. The work is defined in Section 01110 – Summary of Work, and includes but is not limited to the following principal features:

A. Excavation Work and Disposal of Sediment Material from the Yolo Bypass Work (Time and Materials): 1. The project includes providing, when directed, labor, materials and equipment or services, construction equipment, hauling of construction equipment, for excavation and disposal of sediment material from the Yolo Bypass, 2. The extent of the project will be as determined by the Engineer, and the actual amount of work required will be only as directed. No guarantee is made that the work shown or specified in the contract will be needed or directed, and 3. The general scope of the work includes: a. Excavation and disposal of sediment material from the Yolo Bypass, and b. Seeding work.
