Sealed bids for ROOFING REPLACEMENT, WAREHOUSE, CIVIL MAINTENANCE AND WELDING SHOP BUILDINGS, STATE WATER FACILITIES, OROVILLE FIELD DIVISION, BUTTE COUNTY, CALIFORNIA, SPECIFICATION NO. 08-07, CONTRACT NO. C51371, will be received by the Department of Water Resources, 1416 Ninth Street, Room 418, Sacramento, California 95814, not later than 2:00 P.M. on WEDNESDAY, MAY 14, 2008, at which time they will be publicly opened and read at an announced location in the vicinity of such office.

Bid forms for this work are included in a separate booklet titled BID FORM. Bids will be considered only if submitted for all the work required for the above project. The work is defined in Section 01110 – Summary of Work, and includes but is not limited to the following principal features:

Removing and replacing a total of approximately 15,000 square feet of roofing at three structures; the Civil Maintenance building, Warehouse, and Welding Shop at the Oroville Field Division Headquarters. Reroofing work includes: removing and disposing of existing roofing, roof insulation, sheet metal work; replacing gutters and downspouts at one structure; providing tapered roof insulation, cover board, SBS modified bitumen roofing system, reflective roof coating, equipment curb modifications, sheet metal work, sealants, gutters and downspouts; modifying plumbing and electrical to existing equipment; and replacing skylights at one structure.
