Bid forms for this work are included in a separate booklet titled BID FORM. Bids will be considered only if submitted for all the work required for the above project. The work is defined in Section 01110 – Summary of Work, and includes but is not limited to the following principal features:

1. Levee repair at three sites: a. Placement of fencing, b. Removal of approved trees, brush, debris, and other clearing as approved and as necessary for repairs and access only, c. Earthwork operations including excavation, grading, and compaction, d. Import and placement of launch rock, bedding layer, rock slope protection, and agricultural soil, e. Planting, seeding, and irrigation, and f. Plant establishment.
