Sealed bids for SEDIMENT REMOVAL – SYCAMORE CREEK, CHICO AND MUD CREEKS AND SANDY GULCH, SACRAMENTO RIVER FLOOD CONTROL PROJECT, BUTTE COUNTY, CALIFORNIA, SPECIFICATION NO. 10-13, CONTRACT NO. C51419, will be received by the Department of Water Resources, 1416 Ninth Street, Room 418, Sacramento, California 95814, not later than **2:00 P.M. on WEDNESDAY, AUGUST 18, 2010**, at which time they will be publicly opened and read at an announced location in the vicinity of such office.

Bid forms for this work are included in a separate booklet titled BID FORM. Bids will be considered only if submitted for all the work required for the above project. The work is defined in Section 01110 – Summary of Work, and includes but is not limited to the following principal features:

1. Clearing and grubbing excavation area, 2. Earthwork which includes excavating materials, loading, transporting, and stockpiling and pipe crossing of the low flow channel, as shown, 3. Seed stockpile, 4. Construction area traffic control devices and signs, 5. Seed disturbed areas within Sycamore Creek Channel, 6. Seeding and erosion control, and 7. Fencing.

Questions or requests for clarification of the drawings or specifications shall be made in writing at least 10 days before the scheduled opening of bids. Response, if appropriate, will be furnished/sent to all prospective bidders on DWR Planholder's List. A tour or meeting regarding the work site will be scheduled and conducted by the Department. IT IS RECOMMENDED THAT INTERESTED CONTRACTORS ATTEND THE INSPECTION TRIP.

The Department encourages bidders to explore certification as a Small Business and/or Disabled Veteran Business Enterprise and to utilize certified Small Business and Disabled Veteran Business Enterprises during the contract term.
