Sealed bids for FURNISH ANSI BALL VALVES, CITRUS PUMP STATION, CRAFTON HILLS PUMP STATION, AND CHERRY VALLEY PUMP STATION, EAST BRANCH EXTENSION – PHASE II, STATE WATER FACILITIES, CALIFORNIA AQUEDUCT, SANTA ANA DIVISION, SAN BERNARDINO COUNTY, CALIFORNIA, SPECIFICATION NO. 10-18, CONTRACT NO. C51424, will be received by the Department of Water Resources, 1416 Ninth Street, Room 418, Sacramento, California 95814, not later than **2:00 P.M. on WEDNESDAY, DECEMBER 1, 2010**, at which time they will be publicly opened and read at an announced location in the vicinity of such office.

Bid forms for this work are included in a separate booklet titled BID FORM. Bids will be considered only if submitted for all the work required for the above project. The work is defined in Section 01110 – Summary of Work, and includes but is not limited to the following principal features:

1. Manufacturing, shop testing, and delivering ANSI ball valve assemblies including Rexa electrohydraulic actuators (manufactured by Rexa Electrohydraulic Actuation) to San Bernardino Valley Municipal Water District (SBVMWD) Operations Center in San Bernardino, CA as follows: a. Citrus Pump Station (CPS): 1) Four ANSI Class 300 20 inch ball valve assemblies with Rexa electrohydraulic actuators, 2) Two ANSI Class 300 18 inch ball valve assemblies with Rexa electrohydraulic actuators, 3) Two ANSI Class 300 14 inch ball valve assemblies with Rexa electrohydraulic actuators, b. Crafton Hills Pump Station (CHPS): 1) Three ANSI Class 300 20 inch ball valve assemblies with Rexa electrohydraulic actuators, 2) Two additional Rexa electrohydraulic actuators for replacement of actuators in existing ANSI Class 300 18 inch ball valve assemblies, 3) Two additional Rexa electrohydraulic actuators for replacement of actuators in existing ANSI Class 300 14 inch ball valve assemblies, c. Cherry Valley Pump Station (CVPS): 1) One ANSI Class 150 16 inch ball valve assembly with Rexa electrohydraulic actuator, 2. Manufacturing, shop testing, and delivering special tools and spare parts for ANSI ball valve assemblies and Rexa electrohydraulic actuators of each size specified in Subparagraph 1 above to SBVMWD Operations Center, 3. Providing the following services: a. Crane services to unload the equipment at delivery location, b. Services of an erecting representative at each work site, c. Liaison services at the Department's Sacramento headquarters, d. Training program, 4. Field installation and testing of the equipment at various work sites will be done by others under supervision of erecting representative.

Questions relating to bidding may be directed to the Contract Coordinator of DWR in Sacramento, at the contacts listed above. Questions or requests for clarification of the drawings or specifications shall be made in writing at least 10 days before the scheduled opening of bids. Response, if appropriate, will be furnished/sent to all prospective bidders on DWR Planholder's List. A meeting regarding the work site will be scheduled and conducted by the Department. **IT IS RECOMMENDED THAT INTERESTED CONTRACTORS ATTEND THE PRE-BID CONFERENCE.** Contractor's license classification required for this work: N/A .

The Department encourages bidders to explore certification as a Small Business and/or Disabled Veteran Business Enterprise and to utilize certified Small Business and Disabled Veteran Business Enterprises during the contract term.

All bidders shall be prequalified by the Department. Bid documents will be furnished only to prequalified bidders who meet the requirements of the State Contract Act and Document 00040 – Prequalification.
