Sealed bids for SEDIMENT REMOVAL, CORDELIA FOREBAY, STATE WATER FACILITIES, NORTH BAY AQUEDUCT, DELTA FIELD DIVISION, SOLANO COUNTY, CALIFORNIA, SPECIFICATION NO. 11-14, CONTRACT NO. C51443, will be received by the Department of Water Resources, 1416 Ninth Street, Room 418, Sacramento, California 95814, not later than **2:00 P.M. on WEDNESDAY, DECEMBER 28, 2011**, at which time they will be publicly opened and read at an announced location in the vicinity of such office.

Bid forms for this work are included in a separate booklet titled BID FORM. Bids will be considered only if submitted for all the work required for the above project. The work is defined in Section 01110 – Summary of Work, and includes but is not limited to the following principal features:

1. The project includes providing, when directed, labor, materials and equipment or services, construction equipment, hauling of construction equipment, for disposal of sediment from and cleaning of the Cordelia Forebay. 2. The extent of the project will be as determined by the Engineer and the actual amount of work required will be only as directed. No guarantee is made that the work shown or specified in the contract will be needed or directed. 3. The general scope of the work will involve removal and disposal of an estimated 4,000 cubic yards of accumulated sediment from the Cordelia Forebay and liner repair as directed. The sediment will be in a slurry form, as specified in Section 02200 – Time and Materials, in the forebay and will be pumped into tanker trucks. The tanker trucks will transport the slurry to the Travis pond location. The forebay will be available for work from March 12, 2012 to March 26, 2012.

Questions or requests for clarification of the drawings or specifications shall be made in writing at least 10 days before the scheduled opening of bids. Response, if appropriate, will be furnished/sent to all prospective bidders on DWR Planholder's List. A tour or meeting regarding the work site will be scheduled and conducted by the Department. **IT IS RECOMMENDED THAT INTERESTED CONTRACTORS ATTEND THE INSPECTION TRIP.** Contractor's license classification required for this work: A .
