Sealed bids for CRAFTON HILLS PUMP STATION EXPANSION AND CITRUS PUMP STATION – INITIAL, EAST BRANCH EXTENSION – PHASE II, STATE WATER FACILITIES, CALIFORNIA AQUEDUCT, SAN BERNARDINO COUNTY, CALIFORNIA, SPECIFICATION NO. 12-10, CONTRACT NO. C51456, will be received by the Department of Water Resources at the San Bernardino Valley Municipal Water District, 380 East Vanderbilt Way, San Bernardino, California 92408-2725, no later than **11:00 A.M. on THURSDAY, AUGUST 9, 2012**, at which time they will be publicly opened and read at a location in the vicinity of the office.

The work is defined in Section 01110 – Summary of Work, and includes but is not limited to the following principal features:

1. Prestressed concrete forebay water tank.
2. Pump station buildings.
3. Earthwork and shoring.
4. Precast concrete structures.
5. Demolition.
6. Clearing and grubbing.
7. Hydraulic asphalt concrete liner.
8. Steel pipe, fittings, valves and appurtenances.
9. Reinforced hollow concrete masonry structures.
10. Reinforcing steel.
11. Stone slope protection.
12. Metalwork.
13. Aggregate base.
14. Mechanical work.
15. Electrical work.
16. Install Department furnished materials and equipment.
17. Cast-in-place concrete.
18. Coatings.
19. Testing.

Bid forms for this work are included in a separate booklet titled BID FORM, available only from the Department. Bids will be considered only if submitted for all the work required for the above project. Contractor's license classification required for this work: A .

All bidders shall be prequalified by the Department. Bid documents will be furnished only to prequalified bidders who meet the requirements of the State Contract Act and Document 00040 – Prequalification.

The Department encourages bidders to explore certification as a Small Business and/or Disabled Veteran Business Enterprise and to utilize certified Small Business and Disabled Veteran Business Enterprises during the contract term.
