will be received by the Department of Water Resources at the Resources Building, 1416 Ninth Street, Room 418, Sacramento, California 95814, not later than **2:00 P.M. on WEDNESDAY, APRIL 20, 2016**, at which time they will be publicly opened and read at an announced location in the vicinity of such office.

NOTE: Bidders/Visitors should allow sufficient time for checking in with Security upon entering main floor of the Resources Building.

Bid forms for this work are included in a separate booklet titled BID FORM.

Bids will be considered only if submitted for all the work required for the above project. The work is defined in Section 01110 – Summary of Work, and includes the following principal features:

1. Roofing Replacement:
 - a. Locations:
 - 1) Thermalito Pumping-Generating Plant.
 - 2) Annex at Thermalito Pumping-Generating Facilities.
 - 3) Feather River Fish Hatchery Spawning Building.
 - 4) Feather River Fish Hatchery Office and Maintenance Building.
 - 5) Feather River Fish Hatchery Office and Restroom Building.
 - 6) Hyatt Powerplant Air Intake Building.
 - 7) Hyatt Powerplant Access Entrance Tunnel.
 - b. Work:
 - 1) Remove and dispose of existing roofing, roof insulation, expansion joint curbs and covers, edge flashings, counter flashings, roof jacks, skylights, gutters and downspouts as shown.
 - 2) Lead and asbestos hazardous materials are specified in various parts of the project. Abate these materials where shown or noted in specifications as selective demolition or work to be removed.
 - 3) Provide and install Styrene-Butadiene-Sytrene (SBS) modified bitumen roofing system, cover board, tapered and non-tapered rigid insulation, reflective roof coating, curb modifications, sheet metal work, painting and sealants. Also, provide and install skylights, ventilators, gutters, downspouts, internal roof drains, roof accessories, ladders, roof hatches and guardrails where shown.
 - 4) Repair limited metal deck damage at Thermalito Pumping-Generating Plant.
 - 5) Remove limited portion of the metal roof deck at Thermalito Pumping-Generating Plant for new roof hatch.

2. Roofing Repair:

a. Location:

- 1) Oroville O&M Center Plant Maintenance Shop Building.

b. Work:

- 1) Repair and install new flashings, reflective roof coating, paint and sealants, and gutters as shown.
- 2) Abate asbestos materials at repair locations where shown or noted in specifications as selective demolition or work to be removed.

Quantities of work, materials, and equipment required for completion of the work are specified in Document 00410 – Bid Schedule, which is subject to change.

1. WAGE RATES

Pursuant to sections 1770 through 1773.9 of the California Labor Code, the Director of Industrial Relations has determined the general prevailing rate of per diem wages for the locality in which the work is to be performed. Such rates are on file for inspection at the office of the Department of Water Resources, Room 418, 1416 Ninth Street, Sacramento, California 95814. Copies may be obtained from the State of California, Department of Industrial Relations, Office of Policy, Research, and Legislation (OPRL), Labor Research and Statistics Office, P. O. Box 420603, San Francisco, California 94142, telephone (415) 703-4774, fax (415) 703-4771. Prevailing wage determinations may be obtained over the Internet through California Department of Industrial Relations, Division of Labor Statistics and Research's Home Page at <http://www.dir.ca.gov/dlsr/>. The project is subject to compliance monitoring and enforcement by the Department of Industrial Relations.

2. LICENSING

Bidders shall be licensed for the work as required by the Business and Professions Code. Contractor's license classification(s) for this work: C-39 or B w/C-39 Subcontractor; either Contractor or Subcontractor shall be licensed with an asbestos certification (Determined by Contractors' State License Board).

3. BIDDING

Forms of bid and contract, drawings and specifications for the project may be obtained only at the Department of Water Resources, 1416 Ninth Street, Room 418, Sacramento, California 95814, between the hours of 7:30 a.m. – 12:00 noon and 12:30 – 4:00 p.m. or by mail upon written request to the Department of Water Resources, P. Drawings and specifications may be seen at the above location or at Pearblossom Project Headquarters at 34534 116th Street East, P. O. Box 1250, Pearblossom, California 93553.

Drawings and specifications furnished to entities not meeting prequalification or joint venture bidding requirements, or the subcontractors, suppliers, or other parties not interested in bidding on the work, shall not be used for bidding purposes and will be stamped, "Information Copy for Estimating Purposes Only".

4. DVBE AND SMALL BUSINESS PARTICIPATION

Participation by Disabled Veteran Business Enterprises (DVBE) and qualification for Small Business Preference shall be as provided by Document 00206 – Instructions for DVBE Goal and Incentive and Document 00201 – Instructions for Small Business Preference. A DVBE incentive will be applied during bid evaluation in accordance with Document 00206, Paragraph 2 – DVBE Incentive.

In addition, the Department has set a 25 percent Small Business Enterprise (SBE) participation goal in its contracting and is tracking Small Business participation in its contracts. The Department encourages bidders to explore certification as a Small Business and/or Disabled Veteran Business Enterprise and to utilize certified Small Business and Disabled Veteran Business Enterprises during the contract term.

5. CONTRACT COORDINATOR

Questions relating to bidding may be directed to the Contract Coordinator of the Department of Water Resources in Sacramento, at the location or address given above, or at telephone (916) 653-4867. Questions or requests for clarification of the drawings or specifications shall be made in writing at least 10 days before the scheduled opening of bids. Response, if appropriate, will be furnished to all prospective bidders. A tour or meeting regarding the work site will be scheduled and conducted by the Department.

6. PREBID BRAND AND TRADE NAME REQUESTS

Pursuant to Public Contract Code section 10129, alternatives to a designated material, product, thing, or service by specific brand or trade name that are of equal quality and of required characteristics for the purpose intended may be proposed during the bidding period, provided the bidder complies with the following:

- A. Proposals for alternatives to a designated material, product, thing, or service, requested during the bidding period, shall be furnished in writing to the Department's contract coordinator, not later than 14 days prior to the date and time of the bid opening. Proposals requested after issuance of the Notice to Begin Work, shall be submitted pursuant to Document 00706 – Control of Work, Paragraph 4 and Section 01330 – Submittals.
- B. Proposals shall be accompanied by complete information and descriptive data necessary to determine equality of the material, product, thing or service. Samples shall be provided when requested

by the Department. Burden of proof as to availability, comparative quality, suitability, and performance of the material, product, thing, or service shall be upon the bidder. The Department will be the sole judge as to such matters. If the proposal is accepted, bidders will be notified by information letter or addenda pursuant to Document 00200 – Instructions to Bidders, Paragraphs 3 and 4 respectively.

- C. Refer to Document 00706 – Control of Work, Paragraph 6, for substitution requests after issuance of Notice to Begin Work.

7. SUBSTITUTION OF SECURITIES

Pursuant to Public Contract Code section 10263, the successful bidder will be permitted to substitute securities for any moneys withheld by the Department as provided by Public Contract Code section 10261.

8. SAFETY PREQUALIFICATION

Contractors are required to be prequalified by the Department for Safety before they are allowed to bid Department construction projects. This safety prequalification process is intended to provide the Department with knowledge of past and current safety performance of contractors working on Department construction contracts. Contractors will be required to provide information such as Experience Modification Rates (EMR or Ex Mod), injury and illness incidence rates, regulatory citation history, and general safety and health practices prior to bidding on Department construction projects. Contractors will be required to provide full-time safety person or representative if specified thresholds are not met.

Contractors requesting bid documents but are not yet prequalified by the Department for Safety will be provided a booklet “Contractor’s Safety Performance” to be completed and submitted to the Department’s Safety Prequalification Coordinator for review and approval. This is in addition to any other prequalification requirements which may be required for this contract.

9. GENERAL PREQUALIFICATION

All bidders shall be prequalified by the Department. Bid documents will be furnished only to prequalified bidders who meet the requirements of the State Contract Act and Document 00040 – Prequalification.

10. DEPARTMENT OF INDUSTRIAL RELATIONS REGISTRATION AND PREVAILING WAGE MONITORING AND ENFORCEMENT
- A. In addition to complying with other applicable laws, effective for all bids on public works received on or after March 1, 2015, each bidder submitting a bid for such contract work must be a Department of Industrial Relations Registered Contractor pursuant to Labor Code section 1725.5 (“DIR registered contractor”). Under that statute, a Bidder who is not a DIR registered contractor when submitting a bid for the contract work is deemed “not qualified.” Pursuant to Labor Code section 1725.5, all subcontractors identified in a Bidder’s Subcontractor List shall also be DIR registered contractors.
- B. Effective for contracts for public works awarded on or after April 1, 2015, all awarded Prime Contractors, and all subcontractors of any tier, at all times during the performance of the work, shall be DIR registered contractors. Also, all such contractors and subcontractors must furnish electronic certified payroll records directly to the Labor Commissioner (a.k.a. Division of Labor Standards Enforcement). The contracts are subject to compliance monitoring and enforcement by the Department of Industrial Relations.

An inspection trip for prospective bidders will be conducted at selected work site locations. The inspection trip to the various sites is expected to take approximately 2 to 3 hours.

Interested parties are requested to meet **WEDNESDAY, APRIL 6, 2016** at **10:00 A.M.** at the Security Gate Building for Thermalito Pumping-Generating Plant located at 2950 Grand Avenue, Oroville, California, in Butte County. Access to the meeting site is as follows: Via Highway 70 North, take the Grand Avenue exit (Exit 48). Turn left on Grand Avenue. After you pass Gold Country Lane, turn right on the road leading into the Thermalito Pumping-Generating Plant. Proceed to the Security Gate Building on the left side. (See maps on following pages.)

The meeting will start with a brief introduction at the Thermalito Pumping-Generating Plant Annex Building; from there parties will proceed on to visit the project sites at Feather River Fish Hatchery and Hyatt Powerplant. All parties will remain together in a single caravan group, and participants will be escorted at all times through the facilities by Department staff.


