Construction of a Butler-type pre-engineered metal garage shop is being proposed at the DWR Operations and Maintenance (O&M) Center in the city of Oroville, Butte County. The garage shop would be of metal construction and approximately 5,000 square feet. Electric and natural gas service would be supplied to the structure. The garage shop is intended to be used for vehicle storage and mechanical shop space. Additionally, DWR proposes the installation of 3,600 square foot prefabricated modular office building and utilities. Utilities for this modular building would include electricity, water, sanitary sewer, natural gas, and telecommunications.


