

Coachella Valley Integrated Regional Water Management 2015 IRWM Implementation Grant Proposal Authorization and Eligibility Requirements – Project Consistency with an Adopted IRWM Plan

Project Consistency with an Adopted IRWM Plan

Projects covered by this grant proposal are included within the Coachella Valley IRWM Plan, which was adopted by the CVRWWMG governing bodies in March 2014. The IRWM Plan complies with Part 2.2 of Division 6 of the CWC §10530 et al. As the Region is establishing eligibility using an IRWM Plan adopted after September 30, 2008, the final Coachella Valley IRWM Plan is available at <http://cwrwmg.org/library.php> under CVRWWMG Documents.

As stated in section 7.8 of the Coachella Valley IRWM Plan, “the Coachella Valley IRWM project list is continuously updated on the online project database as projects are completed, new projects are added, or changes are made to projects. Project changes can be made by the project proponents as new funding opportunities arise. The projects included in the online project database constitute a living project list that will be continuously updated as the Coachella Valley IRWM Program continues forward.” Projects were chosen for inclusion in this *Coachella Valley 2015 IRWM Implementation Grant Proposal* from the living project list and are thus consistent with the 2014 Coachella Valley IRWM Plan. A copy of the Online Database Project List as of July 2015 is included as **Appendix 1-3**. Please note that the overall grant request and total project costs for the projects have been amended in the Proposal to more accurately reflect project-related expenses as required in the Proposal Solicitation Package.

The following information provides two clarifications about the consistency between projects included in this Proposal and the projects shown in **Appendix 1-3**.

Project 1, the *MSWD Water Supply Water Reliability Project* is a combination of two projects in the online database: *Chromium 6 Wellhead Treatment* and *Automated Meter Reading Pilot Program*. After analyzing projects that were included in the online database, the CVRWWMG and Planning Partners determined that it would be appropriate to combine these two projects to allow Mission Springs Water District to jointly administer a reliability program addressing two major issues throughout its service area.

Project 2, the *Regional Turf Reduction Program*, is a combination of two projects in the online database: *DWA Turf Buy Back* and the *Coachella Water Authority Turf Buy Back*. After vetting projects that were included in the online database, the CVRWWMG and Planning Partners determined that it would be most beneficial to the Region to combine the two turf reduction program to extend grant funding to additional high-priority projects in the Region.

Project 6, the *Shady Lane Water and Sewer Connection Project* is a variation of two projects in the online database: *Shady Lane Sewer Improvement Project* and *Shady Lane Mobilehome Park Water & Wastewater Systems Project*. Both of the projects that were submitted to the online database proposed implementation of measures to provide water-related improvements to the Shady Lane Mobilehome Park. The project that is included in the Proposal was re-formulated to include the highest priority aspects of both projects submitted to the database. This reformulation of the project was approved of by the CVRWWMG, the Planning Partners, and the Local Project Sponsor (Coachella Water Authority) for inclusion in this Proposal.
