

Attachment 1: Authorization and Eligibility Requirements for the Mokelumne /Amador / Calaveras Region

✓ **Project Consistency with an adopted IRWM Plan**

The three projects listed below are included in the adopted Mokelumne-Amador-Calaveras (MAC) IRWM Plan:

- Lake Camanche Service Lateral Replacement – Phase 3
- Sheep Ranch Water Treatment Plant Compliance Project
- MAC Region Water Conservation Program

Between January 2015 and April 2015 the MAC Region initiated the multi-step process of updating its project list, including conducting a ‘call for projects’, screening and evaluating proposed projects, presenting and evaluating results to the MAC Plan Regional Participants Committee (RPC), modifying and integrating project proposals to enhance project benefits and efficiencies, and finalizing the Updated Project List. The Updated Project List was approved at the April 24, 2015 UMRWA meeting and added as an addendum to the MAC IRWM Plan. The MAC Plan Project List Update Addendum 2015 is provided in Appendix 1.3.

MAC Plan – Project List Update Addendum 2015

Introduction

This addendum to the Mokelumne-Amador-Calaveras Integrated Regional Water Management Plan (MAC Plan) documents the changes to the Project List contained in the January 2013 MAC Plan update. The primary purpose for updating the Project List is to better position the MAC Region to compete for additional grant funding associated with Proposition 1 (approved by California voters in November 2014) and other potential funding opportunities.

Project List Update Process Summary

The Upper Mokelumne River Watershed Authority (UMRWA) in October 2014 engaged the services of RMC Water & Environment to administer and support the Project List update process. RMC in January 2015 initiated the multi-step update process with the MAC Plan Regional Participants Committee (RPC). The process included revising the project proposal forms, conducting a ‘call for projects’, screening and evaluating proposed projects, presenting the evaluation results to the RPC, modifying and integrating project proposals to enhance project benefits and efficiencies, and finalizing the updated Project List.

A total of 48 project proposals were submitted, all of which passed the initial screening (based on the criteria specified in the 2013 MAC Plan). Two RPC meetings were conducted, both held at the Amador County Administration Building in Jackson, California, to vet and revise the proposed projects. Table 1 below presents the update process steps and timeline.
