RESOLUTION NO. 92-503

WHEREAS, the Boards of Directors of the Santa Barbara Resource Conservation District, the Santa Maria Valley Resource Conservation District and the Cuyama Resource Conservation District have made resolutions of application to the Santa Barbara County Local Agency Formation Commission (LAFCO) for a reorganization that includes the consolidation of the three districts into one and the annexation of territory to that new district; and

WHEREAS, LAFCO has approved the proposed reorganization and the Board of Supervisors is required to order the reorganization without an election unless sufficient protests are filed; and

WHEREAS, This Board has conducted a public hearing on the reorganization, at which hearing insufficient written protests were filed pursuant to Section 57078 of the Government Code to terminate proceedings;

NOW, THEREFORE, BE IT ORDERED AND RESOLVED by the Board of

EXHIBIT C

Supervisors of the County of Santa Barbara as follows:

1. The above findings and recitations are true.

2. The Santa Barbara Resource Conservation District, the Santa Maria Valley Resource Conservation District, and the Cuyama Resource Conservation District are consolidated into one district which shall be named the Cachuma Resource Conservation District and the remaining territory in the County of Santa Barbara which is not located in the Lompoc Resource Conservation District is annexed to the said Cachuma Resource Conservation District. This reorganization is approved without an election unless a petition requesting an election is filed within 30 days of this date in accordance with Section 57081 of the Government Code.

3. In accordance with Section 57082 of the Government Code it is determined:

(a) This action is being taken pursuant to the Cortese-Knox Local Government Reorganization Act of 1985 (Division 3, Title 5 of the Government Code).

(b) The proposal includes the consolidation of resource conservation districts and the annexation of territory to the new consolidated district.

(c) The proposed resource conservation district shall include all territory in Santa Barbara County outside of the Lompoc Resource Conservation District and those portions of Kern and San Luis Obispo Counties that are currently located in the Cuyama Resource Conservation District or the Santa Maria Valley Resource Conservation District.

(d) The name of the new district shall be the Cachuma Resource Conservation District.

(e) The terms and conditions upon which the reorganization was approved by LAFCO are set forth in LAFCO Resolution 92-836 which resolution is hereby incorporated by reference.

(f) The reasons for the reorganization as set forth in the resolutions of application are to eliminate and consolidate duplicate functions, facilitate short and long range planning, reduce cost, maximize resources and improve fiscal planning.

(g) The regular county assessment roll and the supplemental county assessment roll will be utilized if the reorganization is approved.

(h) Pursuant to Section 57502 of the Government Code, the territory of the consolidated district shall be liable for payments of principal, interest and any other amounts which shall become due on account of any outstanding or then authorized but thereafter issued bonds, including revenue bonds, or other contracts or obligations of the predecessor districts, and shall be subject to the levying or fixing and collection of any (i) taxes or assessments, or (ii) service charges, rentals or rates, or (iii) both, as may be necessary to provide for such payment.
