**RESOLUTION NO. 06-07-01**

**WHEREAS**, the Stockton East Water District adopted a Groundwater Management Plan in accordance with Assembly Bill 3030 in September 1995; and

**WHEREAS**, the purpose of the Stockton East Water District's Groundwater Management Plan is to protect existing water supplies and relieve pressure on the groundwater basin by seeking supplemental surface water supplies for conjunctive use; and

**WHEREAS**, the Northeastern San Joaquin County Groundwater Banking Authority has prepared and adopted the Eastern San Joaquin Groundwater Basin Groundwater Management Plan in compliance with AB 3030, SB 1938, and pursuant to California Water Code Section 10750 et. Seq.; and

**WHEREAS**, the Northeastern San Joaquin County Groundwater Banking Authority (GBA) has encouraged and accepted the participation of agencies and interests who overly or have vested interest in the health and sustainability of the underlying Basin; and

**WHEREAS**, the purpose of the Eastern San Joaquin Groundwater Basin Groundwater Management Plan is to review, enhance, assess and coordinate existing groundwater management policies and programs in Eastern San Joaquin County and to develop new policies and programs to ensure the long-term sustainability of groundwater resources in Eastern San Joaquin County;


