Proposition 84 IRWM

- ▶ \$1 Billion total authorized
- ▶ 4 Rounds of Implementation Grants (\$808.5M)
 - ▶ Round 1 = \$205M – Awarded in 2011
 - ▶ Round 2 = \$151M – Awarded February 2014
 - ▶ 2014 Drought = \$221M – Awarded October 2014
 - ▶ 2015 Round = \$231.5M

2015 Imp. Grant Solicitation Summary

- ▶ Final Guidelines and Proposal Solicitation Package Issued May 2015
- ▶ Applications Due August 7, 2015
- ▶ 37 Applications Received
 - ▶ Total funds requested = \$306.5M
 - ▶ Total project costs = \$1.1B
 - ▶ Total number of projects = 172

Summary of Application Review

- ▶ Scoring system
 - ▶ Proposal level 5 questions for 7 points
 - ▶ Project level 18 questions for 22 points; averaged over all projects
 - ▶ Tie breaker – based on Program Preferences 4 points
 - ▶ None applied at this point
- ▶ Scores ranged from 27 to 12; max possible = 29
