ORDINANCE 2007-02

AN ORDINANCE OF THE SQUAW VALLEY PUBLIC SERVICE DISTRICT ADOPTING AN OLYMPIC VALLEY GROUNDWATER MANAGEMENT PLAN AND ADOPT A FINDING OF EXEMPTION FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT

WHEREAS, in September 2002 Senate Bill 1938 amended sections of the Water Code related to groundwater management; and

WHEREAS, Senate Bill 1938 requires any public agency seeking State funds administered through the California Department of Water Resources for groundwater-related activities to prepare and implement a groundwater management plan with certain specified components; and

WHEREAS, the Board of Directors of the Squaw Valley Public Service District adopted a Resolution of Intent to Draft the Squaw (sic) Valley Groundwater Management Plan on May 30, 2006 as Resolution Number 2006-10; and

WHEREAS, the Olympic Valley Groundwater Management Plan was created for the purposes of protecting and preserving the groundwater resources in the Olympic Valley Groundwater Basin; and

WHEREAS, the Olympic Valley Groundwater Management Plan will further ongoing efforts to protect groundwater and interdependent environmental resources in the Olympic Valley Groundwater Basin, will facilitate collection of information to further understand and evaluate additional policies and programs for protection of groundwater resources in the Olympic Valley Groundwater Basin.

BE IT ORDAINED BY THE BOARD OF DIRECTORS OF THE SQUAW VALLEY PUBLIC SERVICE DISTRICT ADOPTS:

1. The Olympic Valley Groundwater Management Plan for the Olympic Valley Groundwater Basin in Placer County, California, within the Public Service District's jurisdictional boundary, copy of which is on file in the office of the Secretary to the Board of Directors.

2. The Board of Directors further finds that the adoption of the Olympic Valley Groundwater Management Plan is exempt from the requirements of the California Environmental Quality Act (CEQA Guidelines §§ 15061(a)(b)(1)(2), 15262, 15306).

Introduced for adoption at a regular meeting of the Board of Directors of the Squaw Valley Public Service District on April 24, 2007 upon motion made by Directors Wilcox/Dutton; vote was unanimous.

PASSED AND ADOPTED this 29th day of May, 2007, at a regular meeting of the Board of Directors of the Squaw Valley Public Service District by the following vote:


