**RESOLUTION OF THE BOARD OF DIRECTORS OF SOUTH ORANGE COUNTY
WASTEWATER AUTHORITY AUTHORIZING 2014 WATER-ENERGY GRANT
APPLICATION TO CALIFORNIA DEPARTMENT OF WATER RESOURCES
(SENATE BILL NO. 103 SECTION 11 (2013-2014 REGULAR SESSION)) AND
AUTHORIZING THE GENERAL MANAGER EXECUTE A GRANT AGREEMENT
FOR THE ENERGY EFFICIENCY PROJECT
COASTAL TREATMENT PLANT WATER AND ENERGY EFFICIENCY PROJECT**

WHEREAS, the Board of Directors of the South Orange County Wastewater Authority (SOCWA), on behalf of its intends to authorize an application to the California Department of Water Resources (DWR) to obtain a 2014 Water-Energy Grant pursuant to Senate Bill No. 103 Section 11 (2013-2014 Regular Session) (“Grant”), and further to authorize SOCWA to enter into an agreement to receive the Grant for the Coastal Treatment Plant Water and Energy Efficiency Project (“Project”); and

WHEREAS, the Project is for the benefit of PC 15 and the member agencies of PC 15, those agencies being the co-owners of capacity in the Coastal Treatment Plant and facilities, and the Grant and the Project shall be carried out consistent with the obligations of PC 15 and its’ member agencies under the Project Committee No. 15 agreements governing the construction, operation and maintenance of the Coastal Treatment Plant.

NOW, THEREFORE, THE BOARD OF DIRECTORS OF THE SOUTH ORANGE COUNTY WASTEWATER AUTHORITY DOES HEREBY RESOLVE, DETERMINE AND ORDER AS FOLLOWS:

Section 1. The foregoing recitals are incorporated in this Resolution.

Section 2. The General Manager of SOCWA, or her designee, is hereby authorized and directed to prepare required data and to conduct any review and necessary investigation in connection with the Grant application, and to file the Grant application and execute a Grant agreement and any amendments thereto with California Department of Water Resources in connection with the Project.
