SUBJECT Orders Enlarging
Watermaster Service Areas

The attached orders amend the Cow Creek Watermaster Service Area and the Hat Creek Watermaster Service Area by including certain lands and water rights described in the orders.

The Cow Creek Watermaster Service Area is enlarged to include the lands and water rights defined in Application No. 11581 which we have found necessary to regulate unofficially in the past.

The Hat Creek Watermaster Service Area is enlarged to include lands and water rights defined in Decree No. 5724, Superior Court of Shasta County. These lands were previously owned by an Indian and not included within the area. These lands and water rights have now been sold to a non-Indian and should be included in the area.



California, on September 11, 1929, to include the water rights
as set forth in Decree No. 5724 entitled "Doyel Vs. Massie"
entered in the Superior Court, Shasta County, and amended
March 26, 1942, to include the water rights as set forth in
Decree No. 7858 in the Superior Court, Shasta County, entitled
"Doyel Vs. Wilcox" and those rights defined in Licenses 1196
and 2083; and


