1/	The place of use of all Mill Creek water rights are located within the Oak Run Creek drainage basin. The Welch-Strayer Ditch water rights are diverted from Mill Creek (see footnote 3) into Oak Run Creek, then rediverted from Oak Run Creek at Diversion #9. The Excelsior Ditch water rights are diverted from Mill Creek and conveyed directly to the place of use within the Oak Run Creek basin. The Mill Creek water rights are superior to all other decreed North Cow Creek water rights.			
2/	See Oak Run Field Schedule for present owners of Welch-Strayer Ditch water rights.			
3/	The Welch - Strayer Ditch washed-out prior to 1931 and has been abandoned for many years. The Excelsior Ditch users have allowed the Welch-Strayer Ditch users to use the Excelsior Ditch to divert their water rights from Mill Creek. In exchange, the Excelsior Ditch users receive 50 % of the combined water rights instead of their decreed water right of 40 % (2.0 of 5.0 cfs).			
4/	Decreed water right for Tract 17 was 0.50 cfs. Prior to 1943, entire water right was transferred to Tract 30. After this transfer (date unknown), 0.25 cfs was transferred to Tract 29. See Shasta County Official Records Book 166, Page 29 and Book 1177, Pages 264 thru 266.???
