### Agendas now posted for January's regional forums

The agendas for three regional forums next month have been posted on the California Water Plan Update 2013 website [here](#). The planned forums are: Jan. 17, Tulare Lake Region; Jan. 18, San Joaquin River Region; and Jan. 20, Sacramento River Region. Workshops on planning for uncertain future in the Central Valley will coincide with the regional forums. The workshops will help shape regional strategies that will be included in the Water Plan.

### DWR announces final awards of Prop. 1E stormwater flood grants

DWR has listed the final awards for the Proposition 1E Round 1 Stormwater Flood Management Grant Program. [It can be found here](#). ### Proposed water conservation measures set for release on Friday, Jan. 6

On Jan. 6, DWR and the Commercial, Industrial and Institutional (CII) Task Force plans to release SBX7-7 alternative water conservation measures for CII users. The proposed alternative "best management practices" (BMPs) are intended to guide water users in how to operate more efficiently in order to better conserve water. The proposed alternatives are listed in a draft report to the Legislature that will be presented at a public workshop on Thursday Jan. 12 in Sacramento.
