### Water Plan Public Advisory Committee meeting next week

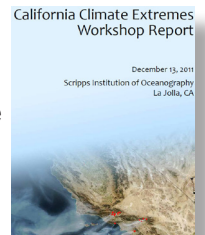

### IRWM climate change considerations discussed in new DWR report

How integrated regional water management (IRWM) regions are meeting requirements to address climate change vulnerabilities is the topic of a new report from DWR. [Climate Change and Integrated Regional Water Management in California: A Preliminary Assessment of Regional Approaches](#) also identifies key considerations in analyzing and adapting to climate change risks within an adaptive management framework.

### Report recaps details from state workshop on extreme climate events

A report posted online provides details on last December's [California Climate Extremes Workshop](#). Presenters at the workshop offered information on extreme weather events and how they could evolve in a changing climate during the rest of the century. The workshop was part of Gov. Edmund G. ### Comment period for agency's tribal communication policy closes next month

July 15, is the deadline for [submitting comments](#) on the California Natural Resources Agency's [draft policy](#) to increase communication and collaboration with the state's Native American tribes.
