### Board gives unanimous approval to Central Valley Flood Protection Plan

The Central Valley Flood Protection Board has unanimously adopted the [Central Valley Flood Protection Plan](#). The comprehensive framework provides details for flood management and flood risk reduction in the Sacramento and San Joaquin river basins. ### DWR posts draft PSP for up to \$25 million in flood management projects

DWR has posted a [draft proposal solicitation package](#) (PSP) for up to \$25 million in funding for projects that integrate environmental stewardship and sustainability principles into flood management activities. After the draft PSP is finalized, an announcement will be made to open the solicitation period for concept proposals. Details are available on the DWR [website](#).
