DSC sets a new timeline for the development of a final Delta Plan

The Delta Stewardship Council (DSC) has [updated the timeline](#) for completion of the [Delta Plan](#). It calls for the final draft of the plan to be posted on Friday, Nov. 30. There are also new timelines for the recirculation of the programmatic environmental impact report and the notice of proposed rulemaking. The final versions of all these documents are expected to be certified or adopted in spring 2013.
