[Save the dates](#) for the upcoming Integrated Water Management Summit and the Integrated Regional Water Management Conference. Both will be in Sacramento: the summit on April 3, and the conference on April 4 and 5. They will include discussions about the challenges and opportunities that exist in flood, ecosystem and water management.

Details will be available in an upcoming edition of the California Water Plan eNews. During the summit and conference, the new Water 360 initiative will be launched. It describes a campaign to promote a vision of integrated water management across the state.



Stakeholder committee to discuss amending ag water regulation form

Discussion of amending the [Agricultural Water Measurement Regulation](#) is on the agenda for an Agricultural Stakeholders Committee meeting that will be [webcast](#) Friday, Feb. 1. The committee will look at [revising](#) the aggregated farm-gate delivery form. The current form may create problems because it requires reporting of water use over portions of two different water years.

Biodiversity council posts updated agenda for program alignment meeting

An updated [agenda](#) has been posted for the [California Biodiversity Council](#) meeting on Wednesday, Feb. 6, at UC Davis.

The day-long meeting will focus on aligning government programs to improve conservation efforts in California. There is no fee to attend, but [online registration](#) is requested.



Three districts receive \$50,000 grants for water management plans

Violations of water standards found in dozens of small community systems

The California Department of Public Health has [released a list](#) of dozens of small community public water systems that violate at least one drinking water standard. The systems were identified under the [Small Water Systems Program Plan](#). The goal is to have all the systems back in compliance by the end of next year.
