

Draft strategic plan charts course for groundwater sustainability in California

DWR's [Sustainable Groundwater Management \(SGM\) Program](#) has released a [draft strategic plan](#) that charts a course for carrying out the [Sustainable Groundwater Management Act](#). The draft plan describes actions that need to be taken during the next several years to help local agencies achieve sustainable groundwater management. Comments must be submitted by June 1. Instructions are on the SGM home page.



2015 Implementation Grant Solicitation draft guidelines and PSP released by DWR

The [draft guidelines](#) and [proposal solicitation package](#) (PSP) for the Proposition 84 implementation grant solicitation are available online. Details are available on DWR's [Integrated Regional Water Management](#) site. Public comment meetings have been scheduled for April 17, in Sacramento, and April 22, in Chino. The deadline for written comments on the guidelines and PSP is Friday, April 24.

It covers the three hydrologic regions in the Central Valley: Sacramento River, San Joaquin River, and Tulare Lake.
