

Updated Model Water Efficient Landscape Ordinance WORKSHOPS

The California Department of Water Resources has recently adopted the updated Model Water Efficient Landscape Ordinance. The ordinance became effective on September 10, 2009. DWR is partnering with the California Urban Water Conservation Council and various organizations throughout the state to conduct a series of workshops. The workshops will assist local governments and urban water suppliers in adopting and implementing the Model Ordinance, or a local ordinance that is at least as effective as the Model Ordinance.

The law requires cities and counties, including charter cities and charter counties, to adopt landscape water conservation ordinances by January 1, 2010.

These workshops are designed to provide guidance and information on the following:

- The content of the Model Ordinance
- Cities and counties roles and responsibilities
- Assistance available to local governments
- Water purveyors roles
- Experiences of local governments and water purveyors
- Benefits of adopting and implementing an ordinance
