Year-long workshop series planned to develop graphics for Water Plan 2013

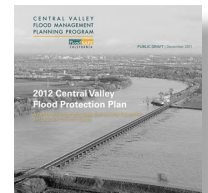

Public draft of Central Valley Flood Protection Plan made available on website

The [Public Draft 2012 Central Valley Flood Protection Plan](#) is being made available on the DWR website. The plan will be presented to the Central Valley Flood Protection Board at its meeting on Friday, Jan. 27. The draft recommends a statewide investment approach for improving public safety, ecosystem conditions and economic sustainability, while recognizing the financial challenges being faced by government agencies.
