Back-to-back Water Plan meetings on tap for next Wednesday

Back-to-back meetings for [California Water Plan Update 2013](#) will be held in Sacramento on Wednesday, Feb. 13. The [Statewide Water Analysis Network](#) will meet in the morning to discuss a framework for Water Plan future scenarios, including analytical tools and methods used to evaluate how water management is affected by a variety of factors. In the afternoon, the [Flood Caucus](#) will discuss key flood management messages for the Water Plan.

Public Advisory Committee to get progress report on Water Plan objectives

A progress report on the objectives and recommendations in [California Water Plan Update 2009](#) will be presented at the [Public Advisory Committee](#) meeting on Thursday, Feb. 14, in Sacramento. There will also be discussion of key objectives for Water Plan 2013, a preview of the April Integrated Water Management [Summit and Conference](#) and status of the [20x2020](#) urban water conservation initiative.

Governor, Legislature receive report on contaminated drinking water supplies

A [report](#) sent to the governor and Legislature by the California Water Boards shows that a significant number of communities in the state rely on a contaminated groundwater source for their drinking water supplies. The report also identifies contaminants and chemical constituents, along with potential solutions. Details are available in this [news release](#).



Groundwater workshop offers help in developing collaborative leadership

The Groundwater Resources Association of California is offering a [workshop on negotiating relationships](#) to improve groundwater planning. It will look at the ways collaborative leadership can bring together diverse stakeholders and help develop a consensus on water plans and projects. The workshop will be Tuesday, March 5, in Sacramento.

Sacramento River Watershed Program revises 2013 workshop schedule

The Sacramento River Watershed Program has released a [revised schedule](#) for this year's watershed workshops. The first series of 2013 will look at watershed restoration. The second series will deal with monitoring and adaptive management for watersheds.
